Parry Organic Spirulina is manufactured in Southern India, using purified groundwater, 100% vegan and organic certified nutrients. It also meets the highest global standards for Organic and is non-GMO verified.

The new & updated Certificate of Analysis for Parry Organic Spirulina (with USP logo) contains 32 parameters covered under product description, physical & chemical analysis, phyto-pigment analysis, fatty acid profile, microbial analysis, heavy metals and contaminants analysis. The key nutritional profile includes protein, phyto-pigment analysis (total carotenoids, beta-carotene, pure phycocyanin, chlorophyll A) & fatty acid profile (gamma linolenic acid, linoleic acid, palmitic acid, stearic acid).
